Dear TSA Member,

It was brought to the TSA's attention that Medicare began to erroneously deny acute pain blocks when performed in conjunction with lines after their April 1, 2009 system upgrade. Upon research we found that this error was corrected by CMS on October 1st and that they are accepting appeals for claims denied from April 1st through September 30th. They are not automatically reconsidering the claims; therefore, each practice will have to send in appeals for reprocessing. A few Texas anesthesia groups have already appealed their denied claims and the claims have been reconsidered and paid correctly by Medicare.

Following is a spreadsheet of the CMS CCI edits. The code in Column 1 is the primary code (in this instance, the lines). The code in Column 2 is the procedure that is considered to be bundled into the line (all pain codes are listed). The effective date is when the bundling went into effect and, as you can see, the deletion date is the same – this removes the erroneous CCI edit. The modifier column provides information as to allowing override of the bundling edit but using the 59 modifier. If there is a "1", the 59 modifier is allowed to be used to signify that the block was a separately identifiable procedure and should be allowed in addition to the line. A "0" means that you cannot override the edit. A "9" is there to designate an entry that exists solely because of the error and has been corrected. So, in example, a single shot epidural is no longer bundled into the central line and will be paid without the need of a modifier while an epidural catheter can be placed in conjunction with a line but will need a 59 modifier to be considered for payment.

You may want to consider reviewing any claims with a line and block code from April 1-September 30, 2009 and resubmit them to Medicare with the appropriate modifiers (as indicated) for reconsideration.
